**A Resolution to Confirm the Undergraduate Student Government Issue Committee
Directors for the 2023 –2024 Academic year**

President Bobby McAlpine (for himself, and Vice President Madison Mason) introduced the following resolution to the Oversight Committee where it passed, and to the floor where it passed.

Whereas Julia Meyer has been nominated to serve as Co-Director of Student Affairs for the 2023- 2024 academic year; and

Whereas Rut Bansal has been nominated to serve as Co-Director of Student Affairs for the 2023- 2024 academic year; and

Whereas Lilly Des Rosiers has been nominated to serve as the Director of Sustainability for the 2023- 2024 academic year.

Whereas Ian Logan has been nominated to reserve as the Director of Membership and Recruitment for the 2023- 2024 academic year.

Whereas Virang Desai has been nominated to serve as the Director of Research for the 2023- 2024 academic year.


Whereas Angela Harper has been nominated to serve as the Director of Data Management for the 2023- 2024 academic year.
