**A Resolution to Amend 56-R-1, 56-R-2, 56-R-3, 56-R-4, and 56-B-1**

Keyanah Peters (for herself) introduced the following resolution to the Oversight Committee where it passed. Then, to the floor where it passed.

**Whereas** the Undergraduate Student Government represents all undergraduate students at The Ohio State University; and

**Whereas** the General Assembly passed 56-R-1, 56-R-2, 56-R-3, and 56-R-4 during the second session of the 56<sup>th</sup> General Assembly on April 19<sup>th</sup>, 2023; and

**Whereas** these resolutions approved the executive appointments for Senior Staff, Cabinet Directors, Black Caucus Vice Chairs, and Undergraduate Caucus Vice Chairs respectively; and

**Whereas** the General Assembly passed 56-B-1: A Bill to Approve the Undergraduate Student Government 2023 Summer Semester Budget during the third session of the 56<sup>th</sup> General Assembly on July 27<sup>th</sup>, 2023; and

**Whereas** the former Speaker of the 56<sup>th</sup> General Assembly did not sign and deliver these pieces of legislation to President Bobby McAlpine as required by the Undergraduate Student Government's Organizational Bylaws and has not been able to rectify this issue in a timely manner; and

**Whereas** in order to properly pass this legislation as required by the Bylaws, the legislation must be amended by the General Assembly to allow the current Speaker to sign and deliver it to President McAlpine.

**Therefore, Let it Be Resolved** that the Undergraduate Student Government amends 56-R-1: A Resolution to Confirm the Undergraduate Student Government Senior Staff for the 2023-2024 Academic Year to change the Speaker listed from "Aidan McLaughlin" to "Alex Poling"; and




