**Whereas** Matt Levine has been nominated to serve as the Senior Director of Operations for the 2024- 2025 academic year; and

**Whereas** Jessica Asante-Tutu has been nominated to serve as the Chair of the Black Caucus for the 2024- 2025 academic year; and

**Whereas** Nigel Gore has been nominated to serve as the Chair of the Undergraduate Caucus for the 2024- 2025 Academic year; and

**Whereas** Aryav Yadapadithaya has been nominated to serve as the Chief Financial Officer for the 2024- 2025 academic year; and

**Whereas** Hanniel Diaz Elizarraga has been nominated to serve as the Senior Director of Allocations for the 2024- 2025 academic year; and

**Whereas** Rishabh Mehta has been nominated to serve as the Senior Initiatives Counselor to the Executives for the 2024- 2025 academic year; and


**Whereas** Hayden Price has been nominated to serve as the Senior Initiatives Counselor to the Executives for the 2024- 2025 academic year; and


**Whereas** Virang Desai has been nominated to serve as the Senior Research Counselor to the Executives for the 2024- 2025 academic year.
