- a. <u>56-R-20</u>: A Resolution to Clarify the Pass/Non-Pass Option for <u>Undergraduate Students Enrolled in Graduate Courses</u>
  - i. For anybody that doesn't know, undergraduate students have a PA/NP grading option available to us. Graduate students do NOT have this option available to them. The GSH makes it clear that undergraduate students can enroll in graduate classes under certain circumstances but does not make any mention of the availability of

the PA/NP option to these students. There may be certain circumstances where undergrads can use PA/NP in graduate classes, and certain circumstances where they cannot. It may be beneficial for undergrads to use this option, I for one will be using it next semester. Knowledge of the availability of this option may increase the availability of graduate-level coursework for undergraduate students. The GSH is regularly updated by the graduate council, so I feel like it's a reasonable ask to ask that they make the availability of the PA/NP option for undergraduate students enrolled in graduate courses clearer. I also added something about amending the University rules to be more explicit about this. This may be a bigger ask since the board of trustees has to approve any changes.

- b. <u>56-R-21</u>: A Resolution to Encourage the Adoption of Generative AI <u>Syllabus Statements</u>
  - i. ChatGPT and other generative AI tools like it have obviously been a huge thing over about the past year. Misuse of these tools has been a big deal for the University, but it's not always entirely clear to students what constitutes misuse. The point of a syllabus is to make the rules and expectations of a class clear, so I think syllabi should specifically address the instructor's policy on generative AI tools. Currently, syllabi tend to either provide a link to the student code of conduct, which, as of 2 weeks ago, did add a brief line about generative AI. It says "UNAUTHORIZED" use of generative ai is prohibited. Other syllabi may state that "some instructors may approve of using generative ai tools for a given course." This doesn't make much sense to me because the syllabus is written BY a specific instructor FOR a specific course, they should instead be giving THEIR policy for THEIR course. Syllabi aren't really regulated at any top level, but there are resources that the university provides to instructors that may encourage certain items. In fact, this was how USG was previously successful in getting the mental health statement to be widely included in syllabi. Overall, I'd like this to be a part of a larger conversation that encourages instructors to really

evaluate their police on generative ai and make informed decisions, but I think a more immediate, tangible outcome would be to add a statement on the office of undergraduate education's recommended syllabus statements web page that USG encourages this, like they currently have under the mental health statement.
