- b. **56- R- 22: A Resolution to Urge The Ohio State University To Allow Students To Attend Any Lecture or Recitation Virtually On November 5, 2024**

- **Bernard:** Asking students to attend lectures and recitation online on November 5, 2024, as it is the federal election and we have a presidential and senate election. Research shows that students tend to be politically active, but classes get in the way. Other universities have done this or gone further. The university showed they could do online learning without learning less as they went through COVID-19. I specified Lecture and recitation as I worried the university would be opposed to labs

as those would be hard to do online. This is very doable we wanted the ask to be very narrow.
