- a. 57-R-8: A Resolution to Call Upon The Ohio State University to Increase the Lyft Ride Smart Program Discount
 - i. Hickman: In general, this resolution is regarding the Lyft ride smart program which provides a discount to Lyft for students between certain hours. The idea is to promote safety to help students move around at night. It began in 2019 and started with 5-dollar discounts and then grew to 6.50 and students used 600,000 rides in the 2022-23 school year. Another thing is that it was taken down to 4 dollars. At the same time, we are seeing an inadequate CABS services bus. A lot of students cannot really use these buses to get
