- 2. VP Robinson reiterates that budget looks good and that they made necessary cuts.
- 3. CFO Yadapadithaya: Proud of budget and excited to answer questions
- 4. SDA Diaz: "More than excited" to answer questions

- 1. Alternate Roy: Wants to know about academic enrichment grants
  - a. McAlpine: Limited COKE funds. His mother and grandmother are discussing something in background
  - Yadapadithaya: Academic affairs committee has received funding from Department of Education.
     Wants to add funding for semesters when students will actually be there
- 2. Senator Dobres: Why did we choose 750 as number of shirts to buy? Any way we can get that down?
  - a. CoS Schmidt: We looked at historic precedent. It's important to recruit for USG. Thousands of students

- 3. Senator Braziel: Why pens and notebooks for GA?
  - a. Speaker Bernard: We already have shirts.
- 4. Parliamentarian Griffith: Wants to "rip the band-aid off" and talk about WSJ. Specific numbers on how many students need WSJ? Happy with negotiated rate. Uses word "tremendous". Is there a way to buy subscriptions only for some?
  - a. SDO Price: 20,000 active subscriptions for NYT and expects large amounts of interest for WSJ
  - b. President McAlpine: Talked to former provost. WSJ is one of most requested subscriptions.
  - c. SDO Price: Same deal with WSJ that other Big 10 schools have. Previous SDO was involved in negotiations.
  - d. President McAlpine: Newspapers want everyone to have access.
- 5. Speaker Bernard: USG also discussed 'The Economist' last year. Is this still a possibility?
  - a. SDO Price: Still waiting for accessibility work on WSJ, so they are doing one thing at a time. The Economist and Columbus Dispatch are potential future goals.
