i. McAlpine: Hello everyone, happy to be here. Welcome back from campus, we are excited about the things we are going to be doing this semester. I want to highlight how we are completing our mission of serving the student body. We are bringing back the homecoming picnic for the third time. We are also doing final exam

car packages as well; it is good for mental health as well on campus and we are supporting Columbus businesses as well. Allocations funding of 30,000 dollars this year, which did go down since last year. We wanted to give as much as possible, but with logistics with a few people we came to the 30,000 dollar number. In governmental relations, we are going to have a how-to advocate panel and things related to voter awareness, etc. In health and safety, they are working on a flu shot drive. The NYT subscription is being renewed and you should get it if you aren't because you are technically paying for it. Buckeye road trips are happening by student affairs as well as Buckeye Learn compost training by sustainability. We are trying to push for more sustainability on campus. This is a great budget, and we are going to make this happen.
