- v. *Weisman*: I don't know the exact reason for Article III.A.5, but it may be confusing for voters that slate affiliations are not published on the ballot, because people may be confused or not know who to vote for.
- vi. *Marsilio*: This is simply a wording change and a clarification from previous years. If you'd like a reason, I'd be happy to give you a reason, but it's a wording change, not a content change.
- vii. *Warnimont*: I love the amendment changes and the no ex post facto changes, among others, so I'm totally willing to vote for these bylaws.
- viii. *Frank*: I'd like to commend the Judicial Panel for a job well done on these Election Bylaws.
 - ix. Luther: I just want to say thanks to everyone who came to the meeting we had about Election Bylaw changes and suggestions, and I'm glad we could make lots of great strides as a General Assembly. At the meeting, the use of devices for voting was an important issue that was brought up. Voting on devices is not addressed in the document at all, and I'd just like to bring that up. I'm yielding the rest of my time to Chief Justice Marsilio.
 - x. *Marsilio*: The Judicial Panel expected this question to come up. We have reasons for everything we include, but we don't feel that it's necessary to address this issue in the Election Bylaws.
 - xi. *Marchese*: This is awesome, thank you. I know for a lot of us, this has been intense and crazy, but I'm glad that this is something we've had a long discussion about. There's one thing that doesn't need to be fixed now, but something under the Voter Qualifications section, it doesn't say anything about international students being able to vote for their emissary, but again that's something that doesn't have to be added right now. That being said, I'm really happy with this document and I will be voting for it.
- xii. *Weisman*: I'd like to yield my time to Chief Justice Marsilio to explain why slate affiliations are not published on the ballot.
- xiii. *Marchese*: They've never been published on the ballot, it's just that the Judicial Panel decided to make it an official part of the Election Bylaws this year, rather than just have it as something that's always been done.
