13	Whereas on January 27th, 2017, President Donald J. Trump issued an Executive Order		
14	effectively allowing the President to ban the entry of foreign nationals into the United States, ¹		
15	and		
16			
17	Whereas this Executive Order suspends "nearly all travelers" on passports from Iraq, Syria,		
18	Sudan, Iran, Somalia, Libya, and Yemen from entering the United States, ³ and		
19			
20	Whereas this Executive Order does not protect foreign nationals with approved visas issued for		
21	the purpose of pursuing higher education, ⁴ and		
22			
23	Whereas this Executive Order further states that "at any point" any additional nations may be		
24	submitted for similar treatment, ⁵ and		
25			
26	Whereas The Ohio State University has over 3,000 international undergraduate students, ⁶ and		
27			
28	Whereas the Undergraduate Student Government is obligated to represent the best interests of		
29	its constituents, without regard to nationality;		
30			
31	Therefore Let it Be Resolved that the Undergraduate Student Government at The Ohio State		
32	University opposes the aforementioned Executive Order, and		
33			
34	Let it Be Further Resolved that the General Assembly of the Undergraduate Student		
35	Government recognizes its constitutional duty to "defend the rights of each individual student."
