**Whereas** the candidates for positions on Senior Staff<sup>2</sup> and Directors<sup>3</sup> are judged on their ability to meet the core competencies of the role as well as the fulfilling the positions descriptions, and

**Whereas** the collaborative nature of Senior Staff and Directors makes it essential that all selected candidates meet the core values of the organization and are deemed those who would contribute greatly to a team, and

**Whereas approval** of the Senior Staff and Directors is necessary for an effective Undergraduate Student Government, and
