#### VIII. New Business

- a. 48-R-7 A Resolution to Support Passage of Ohio House Bill 201
  - i. *Cramer*: Everyone, please look up Ohio House Bill 201 right now. There are many stipulations regarding this resolution: person calling has to provide a good faith effort to call for help, be the first one to call, stay on scene, and give his/her real name in order to be covered under this. Representative Stinziano, putting this forward, allows us the chance to let this go forward.
  - ii. Waidelich: Do any of the co-sponsors have anything to add to that?
  - iii. *Ferzacca*: Just a question on HB 201. Let's say it's me and four friends, and I'm the first person to call. Will I not get in trouble while my friends get in trouble?
  - iv. *Cramer*: I'm not a lawyer, and I can't give you a legal definition of that, but the intent is so that people can't blanket themselves in immunity. A lot of the objection coming from county prosecutors who believe that a lot of people will call ahead and run away in order to ensure immunity for themselves.
  - v. *Kaczmarek*: Why does this apply to alcohol and not other drugs?
  - vi. *Cramer*: I looked into both options, but it turns out that Stinziano only created legislation addressing alcohol. I believe

this will be a good stepping stone for the state of Ohio in that direction.

- vii. Glass: Withdrawn.
- viii. *Wydman*: Ohio State's policy is in MOST cases. Is this one in ALL cases?
- ix. *Cramer*: If you're making a good faith effort to reach out, the police officer would not press charges as long as you meet the stipulations of the bill.
- x. *Touvelle*: What kind of prevalence have you seen in which people haven't called?
- xi. *Cramer*: Lines 25-26 notice the footnote number 3. It was a study that happened at Cornell University that noticed that the number of alcohol-related injuries didn't increase significantly, but the number of 911 calls increased by 2.5 times.
- xii. Warnimont: Only alcohol?
- xiii. *Cramer*: Yes.
- xiv. *Underation*: Can you clarify the difference between police officers, prosecutors, and the off-campus police department?
- xv. *Cramer*: The definition is however the state of Ohio currently defines them.
- xvi. *Underation*: So the police officers in this legislation would be?
- xvii. *Cramer*: Assume it would be the Columbus police department.
- xviii. *Bock*: Does the current Ohio State policy apply to University District?
  - xix. *Cramer*: Not on campus, but on what Ohio State owns, e.g. not on High Street.
  - xx. *Belfiglio*: Between 18 and 21? What is the age range of people being protected?
  - xxi. *Cramer*: Anyone under the age of 21.
- xxii. *Underation*: Does this apply to people off campus or just on campus?
- xxiii. *Cramer*: The entire state of Ohio.
- xxiv. Motion to move into discussion.
- xxv. *Warnimont*: Line 28 do you have citations for University of Cincinnati and other universities?
- xxvi. *Cramer*: I apologize. I forgot to put it in.

xxvii. *Marchese*: Friendly amendment "whereas it passed unanimously in steering."

xxviii. *Cramer*: I'll take that as friendly.

xxix. Reed assigned a proxy.

xxx. *Frank*: Friendly amendment to Line 21 please correct "minors" to "underaged persons."

xxxi. *Cramer*: I'll take that as friendly.

xxxii. *Rollins*: Point of information, the term "minors" defined as any one under the age of 21.

xxxiii. *Ferzacca*: Looking through it, "minors" means a person under 18 years of age. Would this actually affect college students above the age of 18?

xxxiv. *Cramer*: Good Samaritan stuff actually starts on page 10. That section would provide amnesty to someone under the age of 18. Last three pages is where the substantive change we're discussing today is located.

xxxv. Motion to close the Speakers List.

xxxvi. *Cramer*: First year students under the age of 21 are more likely to drink excessively. For living area senators, I'd like to say that this would directly affect your constituents.
